

(ACT NO. 54 OF 1972)****WITHDRAWAL OF GOVERNMENT NOTICE 5960 PUBLISHED IN GOVERNMENT
GAZETTE NO. 52227 OF 07 MARCH 2025**

I, Dr Pakishe Aaron Motsoaledi, hereby withdraw Government Notice No. 5960 published in Government Gazette No. 52227 dated 07 March 2025, containing Regulations made in terms of section 15 (1)(b)(e)(g) and (7)(b) of Act No. 54 of 1972 pertaining to the prohibition of the sale, importation and manufacture of foodstuffs containing any part of the plant or component derived from the genus *cannabis sativa*, hemp seed oil or hemp seed flour.
